Agassi Prep Governing Board Unanimously Approves New Lottery Preferences

March application deadline

LAS VEGAS, January 25, 2010– The Governing Board of the Andre Agassi College Preparatory Academy (AACPA) today announced the schedule for 2010-2011 Student Enrollment Applications and its approval of new lottery preferences aimed at serving the most underprivileged students in the area surrounding the school.

"We are excited to begin the 2010-2011 enrollment process and want to make sure that we make every effort to reach out to the widest audience of parents, guardians and caregivers possible about opportunities for their children to attend Agassi Prep," said Agassi Prep's Chancellor Marsha Irvin.

Agassi Prep has always used existing charter law to fulfill its mission and a recent legislative change (AB391) further allows the governing boards of all charter schools in the state to consider additional lottery preferences. As a result, the board incorporated the designation of "economically disadvantaged" into the school's lottery preferences. Agassi Prep will continue to use the "two mile radius" and "sibling" preferences. The approved preferences are listed below.

If more pupils who are eligible apply to AACPA for enrollment for the 2010-2011 school year than the number of spaces which are available, AACPA shall determine which applicants to enroll on the basis of a lottery system. The lottery would be conducted in accordance to **NRS 386.580 Subsection 2 and SB 391 Section 3**. These state approved guidelines establish the following enrollment priorities and allowances (listed in order of priority):

1. Applicants economically disadvantaged with siblings* attending Agassi Prep, during the 2010-2011 school year, and living within a two mile radius of Agassi Prep
2. Applicants economically disadvantaged and living within a two mile radius of Agassi Prep
3. Applicants with siblings attending Agassi Prep, during the 2010-2011 school year and living within a two mile radius of Agassi Prep
4. Applicants living within a two mile radius of Agassi Prep
5. Applicants with siblings* attending Agassi Prep during the 2010-2011 school year
6. Applicants economically disadvantaged and living beyond a two mile radius of Agassi Prep
7. All remaining applicants

All applicants will be placed on a grade level specific randomly generated waiting list which is based on the priorities listed above. The application is valid for the 2010-2011 school year. A new waiting list is generated annually after each lottery on an as needed basis.
